MADS WILL NOT BE RESPONSIBLE FOR ANY CONSEQUENTIAL OR PUNITIVE DAMAGES. The individual whose signature appears on this form is the Owner or has the Owner's authority to enter into a binding contract for the winterization and, if requested, repairs and modifications herein ordered to the described vessel and its equipment. I, the customer, understand that I am taking full liability for my boat. I agree to pay for all services, parts and materials described herein and all other incidental services, parts, supplies and materials which are, in the opinion of MADS Outdoor Products reasonably necessary to perform the work specified by the Owner's instructions. I understand that I will be held responsible for any repairs necessary in the future. Lessor agrees to provide indoor, unheated, locked or outside storage space for stored items described below. The term of the lease shall begin upon the date that Lessee's property enters MADS, no earlier than Labor Day. The lease shall expire upon removal of the stored item. Overall length includes, but is not limited to trailers, hitches, attachments, motors, propellers, winches, and overhangs. The storage fee is for the term of the lease. Provisions for early removal of stored items are at the sole discretion of the Lessor. Inside stored units shall be removed no later than April 15. Lessor may place units outside after this date, and lease will expire. Lessee agrees to hold harmless and indemnify the Lessor from any and all responsibility for damages or injury arising from storage of property at MADS. Lessee agrees to carry adequate insurance to protect Lessee and Lessor from all claims arising from any loss related to this agreement. Lessee further agrees Lessor is not responsible for damage to Lessee's property.
